STEP 1

STEP 3

ShredAssured Recycles:

All of the shredded material that can be recycled goes directly to licensed recyclers.

Destroyed hard drives are melted down and recycled into items such as rebar.

Shredded documents are recycled into materials such as paper towels, toilet paper, cardboard, corrugated boxes, etc.
